 - C. Ensure the hyperlink is working properly and directs the reviewer to the completed and signed Non-Supplanting Attestation Statement information.
 - D. Enter the Date the URL Link was verified on line #3.
 - E. Save the information the school entered on page 4 in preparation for submitting the form as evidence to suffice the Epicenter Title I, Part A Supplement, Not Supplant (SNS) Attestation task.
4. **SCHOOL ACTION:** Upload and submit the required "*Title I, Part A Charter School Non-Supplanting Attestation Statement: Epicenter Task Proof of Evidence*" form to Epicenter to satisfy the Title I, Part A Supplement, Not Supplant Attestation task by the deadline identified.

Title I, Part A: Non-Supplanting Charter School Attestation Template

Supplanting Defined

Title I, Part A federal funds must be used to supplement, not supplant (SNS) existing funds for program activities and must not replace those funds that have been appropriated for the same purpose. Generally, federal funds allocated to are supposed to be additive or supplemental to other funds available to schools. “Non-federal funds,” means only public “state and local funds.” Accordingly, other non-Federal funds, such as private contributions, fundraising, and parent fees, need not be part of determining compliance with the Title I, Part A supplement, not supplant requirement, unless the Nevada Department of Education or SPCSA requires that they be included.

Supplanting shall be the subject of application review, reimbursement request review, amendment review, post-award monitoring, and/or audit reviews. If there is a potential presence of supplanting, the charter holder applicant or grantee will be required to supply documentation demonstrating that the reduction in non-federal resources occurred for reasons other than the receipt or expected receipt of Federal funds. *ESEA section 1118(b)(1)*

*****IMPORTANT NOTE-*** *Supplement, not Supplant (SNS) must be specified in the charter school’s written policies and procedures. It is a criterion identified under Allowability of Costs which is typically collected by the SPCSA through desktop monitoring, generally during the pre-boarding and/or during the onsite monitoring process. The charter school’s written policies will be checked to ensure the supplement, not supplant section meets compliance during the desktop review and/or monitoring process. The supplement, not supplant regulation, is applicable to ALL federal grants under 2 CFR Part 200 §200.302(b)(7), §200.403.*
